President Dr. Kim stated that the minutes had been posted in the APEC website and circulated to all members and hence the meeting accepted that the Minutes be considered as having been read.

There were no comments/suggestions or matters that needed discussion form the minutes.

6. Constitution revision and/or clarification

- i) Article X regarding the Subscriptions and Financial Management: Treasurer Dr. Francis Chan explained the background and the requested contents.
- : Officers and Councillors discussed actively, and some modifications were made in the ByLaw 11 of Article X.
- il) Financial support for the officers including President-elect for APEC congress
- : President explained the necessities to support the Honorary life members and President-elect to the congress.

Officers and councillors agreed with this. But As the ByLaw does not detail it, APEC head office recommend LOC to consider it.

APEC may also consider to use the Annual Sponsoring Budget for this issue.

- iii) Method to nominate and appointing the Committee Chairs
- : President explained the background.

Officers and Councillors discussed actively, and some modifications were made in the ByLaw 4 of Article VIII 1 and ByLaw 5 of Article VIII 3.

- iv) Councilor nomination: "every two-year presently" to "when changed"
- : President explained the background of this suggestion.

Officers and Councillors discussed actively, and Dr. Miglani explained the necessity to keep the original policy (necessities to have the nomination form for every 2-year before the BGM).

Decision made to keep the original policy to nominate the councilor every two year before BGM.

- v) New member countries and region grouping
- : President introduced the new member societies and distribution suggestion to the three regional groups.

ByLaw 13 Article XV 8 was revised to include new member societies.

After discussion as above in each issue, a motion was moved to accept the revision and conclusion. revision of Constitution/ByLaws and the issues above. The revised version was circulated by Dr. Henry Kim to all officers and councillors by email for any further corrections. No more opinion was arisen.

President Dr. Kim stated that all reports were circulated by email before BGM. A motion was moved by Dr. Henry Kim to accept and was accepted unanimously.

8. Issues of Agenda as follow

 - A-1) Online seminar sponsored by the annual sponsor companies (decided by the company and APEC support for promotion and moderation if requested)
 - A-2) Representative speaker support: APEC representative speaker to AAE and future plan to support the speaker: may select representative after their acceptances.
 - A-3) expend target congress (need to consider budget)
 - : A) President explained the history of Annual sponsorship and current situation about it.
 - A-1) APEC online seminar will be promoted by the APEC facebook page and email after APEC 2023 congress.
 - A-2) APEC representative speaker, Dr. Nessrin Taha, joined the AAE23 and gave a lecture. She was supported for the travel (USD 3,000).

For the future support for the representative speakers, Whom got the acceptance from the congress or conference will be reviewed for the financial support. Will be announced in the webpage and facebook as well as email for this issue.

A-3) After active discussion, IFEA and ESE Congresses will target congress to support. Who have acceptance from the AAE, IFEA, and ESE can apply for the support.

 - B-1) Research committee: i) organize research projects, ii) funding research grants including the use of annual sponsoring budget
 - B-2) if we make another committee, we need Chairperson for this and revise the constitution.

 - B-1) Research committee will discuss of the project, the funding and usage of it..
 - B-2) ByLaw 7 Article IX 1 and ByLaw 10 Article IX were added to define the role of APEC President (to appoint the committee chairs) and Research committee.

ByLaw 4 Article VIII 1 was revised (vi and vii) and added (viii).

After hearing each nominee's speech, Dr. Nehme was elected by Simple majority voting (result: 11 to 8).

- Chair of Education Committee: President Dr. Kim and President-elect Dr. Dorn appointed Dr. Mehmet Baybora Kayahan (Turkey)

- Chair of International Outreach Committee: President and President-elect appointed Dr Sanjay Miglani (India) with his dedication for the maintenance of the APEC web page and exploring new member societies
- Chair of Research Committee Councilors: President Dr. Kim and President-elect Dr.
 Dorn (USA) appointed Dr. Mohsen Ramazani

11. Biddings for the 2027 APEC congress

- There was no bidding application till 15 days before the BGM from region C member countries. UAE and Egypt sent an email without bidding form a few days before the BGM.
 - According to the Constitution and ByLaws, these bidding were not considered.
- After confirmed no bid from region C by the due date, Korea submitted the bidding form before the BGM. Dr. Min, Councilor from Korea presented and explained the bidding contents. And decided to have 2027 APEC congress at Korea.
- A motion was moved by Dr. Henry Kim to accept and was accepted unanimously.
- President of Bangladesh endodontic society (BES) and Councilor Dr. Quader Rubel reported the process of 2025 Congress organization.
